



Joint Call on Good Practices for Strengthening Agriculture Innovation Systems in Asia -Pacific

DEADLINE FOR SUBMISSIONS: 30 April 2023

Context

The Asia-Pacific Islands Rural Advisory Services Network (APIRAS) and the Asia-Pacific Association of Agricultural Research Institutions (APAARI) in close collaboration with the Office of Innovation (OIN) at the Food and Agriculture Organization (FAO) of the United Nations are committed to strengthening agriculture innovation systems (AIS) in the Asia-Pacific for the sustainable transformation of agrifood systems. The Tropical Agriculture Platform (TAP) hosted by FAO has developed approaches and tools to strengthen innovation capacities in the agri-food sector. As part of the TAP-AIS project funded by the **European Union**, TAP and its partners aim to strengthen capacities in regional research and extension organizations in order to integrate TAP tools and approaches in their work programmes. This will promote innovation processes at the country level and facilitate and strengthen collaboration and synergies between research and extension organizations at regional and national levels. Despite encouraging signs that AIS approaches are being more widely integrated into national innovation policies and programmes, their successful adoption remains a challenge together with limited documentation and evidence of existing successful practices.

Call on Good Practices

This is a joint call by APIRAS and APAARI for good practices with the aim of documenting and sharing institutional innovations in agri-food research, extension and education. There is a growing recognition of the importance of institutional innovations in promoting more efficient and productive collaboration and knowledge flow among different actors in the AIS.



Institutional innovations are changes in practice, policy, governance, etc., that often challenge standard/existing rules, habits and conventions within organizations and positively influence interactions, collective decision-making processes and actions within one organization or among multiple organizations, thereby enabling innovation and impact at scale. The practices could relate to reforms or changes in financing, partnerships, policies, programmes, use of multi-stakeholder mechanisms such as platforms, capacity development, digitalisation, etc.

4-Step Process









Abstract submission

30 April 2023

If you are interested in writing a Good Practice on the theme, submit an abstract that describes the good practice in not more than 250 words by 30 April 2023 to: networkapiras@gmail.com

Review and selection

15 May 2023

The APIRAS and APAARI technical team will review the abstracts and make a final selection by 15 May 2023. Authors of the selected abstracts will be notified and guided on how to develop a full Good Practice by 15 May 2023

Submission of the Good Practice

30 June 2023

A full Good Practice (max of 2000 words) should be submitted by 30 June 2023 to: networkapiras@ gmail.com

Publication of Good Practice

July 2023

Publication and dissemination of the Good Practice through our platforms with full recognition of your authorship, following the incorporation of comments and suggestions and editing.

What a Good Practice should contain

- **Context** Country, sector, problems and summary of the key institutional innovation
- **The approach -** Rationale, broad principles and concept
- The process Key components, the different actors involved and their roles
- **Progress-** Key outputs, outcomes and evidence of impact of the institutional innovation at the organizational and/or system level
- Challenges Types of challenges faced and how they were addressed
- Lessons learned What worked and what didn't
- **Contact information:** Name, affiliation, e-mail, a stamp-size picture of the author(s)
